as a candidate in a provincial election.

Deputy Party Leader – Will take over as Leader in the event of a vacancy in that position, and may assist the Leader with his or her responsibilities.

Chairman -

shall preside at all Conventions, General Meetings, and meetings of the Executive Committee. The Chairman shall be the Chief Executive Officer of the Party.

Vice-Chairman - shall act as assistant to the Chairman and shall perform the duties of the Chairman in the event that the Chairman is, for any reason, unable to perform the duties of his office.

Campaign Director - shall be the overall campaign manager for the Party. Duties of the Campaign Director shall include acquiring and training candidates, media contact and public relations, working with Constituency Associations, and other political activities as mutually agreed with the Party Leader.

Secretary – shall provide, or making provision for, legal services for the Party; and shall be responsible for the general correspondence of the Party.

Recording Secretary - shall take minutes at all official meetings of the Party and the Executive Committee, maintain the Minute Book of the Party, be responsible for notifying all eligible attendees of the time and place of meetings of the Party and the Executive Committee, and perform all other such duties as may be assigned from time to time.

Treasurer - shall receive, expend, and account for the funds of the Party under the supervision of the Executive Committee. The Treasurer shall serve as the Chief Financial Officer of the Party and shall be responsible for all obligations imposed on the Party by the Commission on Election Finances. The term of the Chief Financial Officer shall coincide with the fiscal year of the party.

Members-at-Large – Two are elected for a one year term to represent the members of the Party at Executive Meetings of the Party.

Ethics Committee – Two members are elected each year for a three-year term. The Ethics Committee deals with any complaint lodged by a Member against an Associate, Member or Party document that violates the Statement of Principals or Statement of Ultimate Goals, or alleged violations of the Constitution or Bylaws by any Officer of the Party.

All Officers must sign an oath of office, which shall read, "I support and promise to uphold the Ontario Libertarian Party Statement of Principles." The Leader and Deputy Leader must also sign the Candidate's Oath, "I will not advocate anything inconsistent with the Ontario Libertarian Party Statement of Principles."

Because this is a business meeting, the Registration fee is treated as a political donation and qualifies for the political tax credit of up to 75%. Register now at www.libertarian.on.ca/ Convention to qualify for the early bird discount. Or complete and return the enclosed registration form.

Party Colours and Logo

Formal amendments propose are listed on page 3-4. Several members are concerned that the Party colours of green and black lead to confusion with the Green Party. When some voters see our green signs they think Green Party. The fact that green has been the Libertarian Party colour since 1975 means little to voters. The Libertarian Party of Canada has adopted gold and blue as their colours, and it would benefit both parties if the Ontario Libertarian Party used the same colours. We would continue to use the trillium, the provincial flower, as our logo.

Libertarians Running Municipally October 2014

The following are short introductions from members Party running municipally this October, taking the same message of libertarian values to the local level. I am sure all could use a hand from anyone local.

Igor Bily

I have been a member of the OLP since 2013 and I'm running for Councillor of Ward 6 in Richmond Hill: an extremely ethnically diverse neighbourhood.

Richmond Hill, previously a financially sound "super-town" with population of 140,000 under late Mayor William Bell, slowly but surely slid into a financial abyss due to reckless spending by a Town Council dominated by social engineers of all stripes. During the last 4 year term town property taxes in Ward 6 grew by 27%, 6% annually, despite the fact Town Hall at the same time almost depleted reserve funds formed as a result of the hydro utility sale. The level of Town services also declines year by year.

In contrast to the incumbent's inaction I propose a free market medicine for this ailing patient:

- Publicly discussed detailed line-by-line budget
- Outsourcing to the private sector
- Truly transparent and fare tender process
- Tight head count control of the Town staff
- Compensations based on the broader job markets rather than on "comparator groups" i.e. other municipalities
- Expansion of user fees for recreation services
- Exclusion of free entertainment delivery through the public library

Proposed Constitutional Amendments

The following amendments to the Party's Constitution (by Jim McIntosh) and Statement of Ultimate Goals (by Neal Donnelly) will be voted on at the Convention on November 2, 2014.

Membership signature online

Article 4 – Membership and Associate Status, Section 1 currently reads, "Anyone who has signed the statement, "I'm for individual liberty," and has paid current membership dues, shall be a "Member" of the Party." Similarly, Section 2 says, "Anyone who has signed the statement, "I wish to be an Associate of the Ontario Libertarian Party," and has paid current membership fees, shall be an Associate of the Party." In order to keep up with technology and the practice of having individuals click a button to signify acceptance of an agreement, the Party has implemented an online membership page where a person who wishes to be a Member of the Party checks a "radio button" to signify that they agree with the statement, "(Member) I am for Individual Liberty." They may alternatively click the radio button beside the statement, "I wish to be an Associate of the Party."

Jim McIntosh MOVES that Sections 1 and 2 of Article 4 of the Constitution be amended as follows (amendment in *italics*):

Anyone who has signed the statement, "I'm for individual liberty" or has indicated agreement with this statement online, and has paid current membership dues, shall be a "Member" of the Party.

Anyone who has signed the statement, "I wish to be an Associate of the Ontario Libertarian Party" or has indicated agreement with this statement online, and has paid current membership fees, shall be an Associate of the Party."

Members-at-Large Oath

Article 5 - OFFICERS, Section 1 reads as follows: "The Officers of the Party shall be a Chairman, a Vice-Chairman, a Secretary, a Recording Secretary, a Treasurer, and a Campaign Director."

Article 6 - EXECUTIVE COMMITTEE, Section 2 reads as follows: "The Executive Committee of the Party shall be composed of: a) the Party Leader and Deputy Party Leader; b) the six Officers of the Party; and c) two Members-at-Large. Article 16 - ELECTION OF PARTY LEADER AND DEPUTY PARTY LEADER, Section 5 reads as follows: "No one shall serve as Party Leader or Deputy Party Leader who has not signed the oath of office and the candidates' pledge." Article 6 - EXECUTIVE COMMITTEE, Section 8 reads as follows: "All Officers must sign an oath of office, which shall read, 'I support and promise to uphold the Ontario Libertarian Party Statement of Principles." Members of the Ethics Committee are also required to sign this oath. However it appears that Members-at-Large were left out.

Jim McIntosh MOVES that Section 8 of Article 6 be amended to read as follows (*italics indicate amendment*);

All Officers members of the Executive Committee must sign an oath of office, which shall read, 'I support and promise to uphold the Ontario Libertarian Party Statement of Principles.'"

Statement of Ultimate Goals F. Monetary Policy

The fourth (and final) item in this section is as follows – "Individuals and corporations may issue their own currency." Member Neal Donnelly MOVES that the fourth (and final) bullet under Section F, Monetary Policy, in the Statement of Ultimate Goals be replaced with the following;

Individuals, associations and enterprises may issue their own currency.
